

### PLANT OF THE MONTH RULES

- \* A maximum of three plants may be entered in each category (cactus and succulent).
- \* There will be two classes of entrants: novice and advanced.
- Intermediate entrants must have had the plant in their possession for at least six months; beginners, for three months.
- Entrants will receive 6 points for first place, 4 points for second place, 2 points for third place, and I point for third showing a plant that does not place.
- \* There may be up to three third places in a category. If plants are not deemed to be of sufficient quality, no place will be awarded.
- Entry tags must be collected by the person in charge of recordkeeping.
- At the annual Christmas party, award plants will by presented to the ten highest cumulative point holders renamiless of class.

### Article XI - Dissolution

Section 1 - The decision to dissolve the South Coast Cactus and Succulent Society (SCC&SS) must be made by majority vote of the Officers - with all Officers present and the President's vote breaking any tie. The President will draft a written motion. The motion must provide a reason for dissolution, a treasurer's report, a proposed plan to dispose of any remaining assets, a specific dissolution date, and a date for mailed in ballots that is at least a week before the next regularly scheduled meeting. The President will direct the Secretary to mail the motion to all current members within seven days. Members may turn in their ballots at the next meeting or mail them to the President before the next meeting.

Section 2 - At the next meeting, the President will appoint two members to count and total the ballots. It requires a two-thirds majority of those members who return their ballots to dissolve the club.

Section 3 - In the event of dissolution, any debt of the SCC&SS shall be paid by assessment of the members. Upon the dissolution all remaining assets after payment or provision for payment of all debts and liabilities shall be distributed on a pro rata share to the members OR to any other entity if proposed at-the final meeting and approved by a majority vote of those present.

Section 4 - In the event the motion is NOT approved. The President will appoint a nominating committee for a new slate of Officers.

## The Virtual Gardener Web Forums & Data Mining

If you haven't participated in a webbased horticultural forum, you should at least give it a try. There are literally thousands of them. And like all groups some are more interesting then others and some groups are more stable than others, often because informed people share their knowledge and experience. Here are a few of the forums in which I have participated in the past or am currently enrolled.

The Garden Web at <a href="http://www.gardenweb.com/">http://www.gardenweb.com/</a> I used to post quite often in the Sansevieria forum, but not so much now. I like the folks who post here and the site allows you to upload photos (jpg files) from your computer - photos that remain on the site permanently. Many participants are willing to exchange plants - often all you have to do is say you are looking for a particular species and someone will offer to trade or sometimes just ask for a mailing address.

Other favorites of mine are at the Yahoo Groups at http://groups.yahoo.com/ Like all these groups, you will be asked to register, but don't let this deter you from finding new friends or free plants and information. Of the 103 Yahoo forums devoted to plants, I belong to three. We tell others of recent acquisitions, about potting mixtures, watering and fertilizing regimens, brag about our plants and successes and seek consolation on our failures. We share lists, references, photos, and often talk about personal stuff. This forum has a "moderator" who can delete off topic posts. I have set up my computer to deliver posts in the "Sansevierias" forum directly to my Outlook Express mailbox, where it is more convenient.

Another popular website is at Dave's Garden (<a href="http://davesgarden.com/">http://davesgarden.com/</a>. Dave's Garden is a huge website that supports about 50 or so forums. I no longer participate, mostly due to time constraints, but it also contains lots of reference material.

A few of these forums are infested with Spam, especially those on the "Usenet" at rec.com. But try a few, before giving up. There are many other forums. They're not hard to find, if you look. I did a google search for "Cactus and Succulent forums" and came up with 92,700 hits!!! If you find one you like, pass the word around.

And what in the world is "data mining"? Simply put, its like going to the library to do research. But it can also be fun when you do it on the web because you often stumble across really interesting stuff. If you're curious like me, "interesting stuff" can lead you to websites that have absolutely nothing to do with horticulture - this is called "surfing". Most people use "search engines" to look for information. The most popular and some say the most effective is Google at www.google.com although Yahoo at www.yahoo.com is not far behind. The Microsoft site at www.MSN.com is a new comer. All have similar attributes. Most people never use the "Image" search, but these are useful if you're looking for a picture of a particular species. If you are getting too many results, try putting your search phrase in quotes.




